## May Meeting

Becki Hoff will present on Employer Compliance with the American with Disabilities Act for our May meeting. Becki is the Vocational Rehabilitation Regional Administrator for Region VIII of the ND Division of Vocational Rehabilitation. She will discuss common issues employers face relating to the American with Disabilities Act. Topics will include: effective communication, employment, hiring, job qualifications, hiring, medical exams, physical access, reasonable accommodations, reasonable modifications, service animals and tax incentives.

#### Main objectives include:

- 1. To understand the basic provisions of the ADA relating to employment.
- 2. Basic ADA issues relating to hiring .
- 3. Recognizing possible requests for reasonable accommodations.
- 4. Available resources.

Becki has worked as a Licensed Social Worker in the medical/mental health field 16 years, then as a case manager for severely mentally ill individuals. She has been employed with North Dakota Vocational Rehabilitation as a Counselor for 9 years and for the past 2 years as the Supervisor of the local office.
